### **BOOKINGS:**

*\*We do not accept last minute services on day of event. Please make sure every person that needs services is listed on the contract. I need a certain amount of time per person to give quality service.*

*\*To secure a date and scheduled make up signed a signed contract is required with a \$50.00 deposit due at time of signing. This price does go toward your total balance. Although, the deposit is NON\_REFUNDABLE AND NON-TRANSFERABLE.*

### **TRAVEL FEE:**

*\*There is a flat fee of \$50.00 for on-location weddings within the Cape Cod area. Anything off Cape is \$75.00.*

### **PARKING FEE:**

*\*Any parking/valet fee's must also be paid for under contract.*

**LIABILITY:**

*\*All brushes and make-up products are kept sanitary. All products are sanitized between every application. Any skin conditions or sensitivities of the client(s) should be reported beforehand prior to application.*

**PAYMENTS:**

*\*The final balance is due on the day of event.*

**CANCELLATION POLICIES:**

*\*Cancellations must be made 30 days prior to your reserved date. Any time less you are responsible for 50% of payment/services agreed upon this contract.*

I also understand that I am responsible for balances from any other members of my party who fail to provide payment.*
